All outlets include 25' of line from the closest available outlet, anything after 25' will incur additional footage charges at \$6 per foot. Size of airline installed is predicated on the exhibitors CFM ordered. Compressed air is available during move in and show hours only. During move out, compressed air will be disconnected two hours after show close. Exhibitors needing air beyond these hours are subject to overtime charges. Yard Plumbing will not be responsible for moisture or water in air lines; Exhibitors should supply their own filters and/or dryers. All distribution of plumbing lines must be completed by Yard Plumbing staff and will be charged accordingly. In order for Yard Plumbing to make a connection, the connection point must have standard pipe thread. All services require labor for installation and dismantle with a minimum of 1 hour install and 1 hour dismantle. Yard Plumbing is not responsible for any debris, sediment or discoloration of water.
